As per the ref.first cited R.V Pradeepan ,Janaki Nivas, Mundayad, Varam, has filed an application in Form-4 under Kerala Conservation of Paddy Land & Wet Land Act- 08(28 of 2008 (G.O (P)611/2015/RD Dt.17/11/2015 for regularisation of 23.31 Ares of land comprised in R.S 19/3 of Chelora Amsom Desom of Kannur Taluk after paying an amount of Rs.500/- towards the application fee as insisted in the G.O referred above.

As per the ref second cited report on application in Form-5 was filed by Village Officer Chelora. As per the report land in question i.e 23.31 ares of land comprised in R.S 19/3 of Chelora Amsom Desom was converted prior to 12/8/2008 and has recommended to grant regularization after collecting an amount of Rs.437063/- i.e 25% of fairvalue fixed for the 23.31ares of land in question.In continuation hearing in this case was conducted on 29/06/2016 @ 3 p.m both Village Officer Chelora and the applicant were present.After conducting the hearing .VO stated that this land has coconut trees of more than 15 years old and that it is not a paddy land. The photos also state the same. He wants to construct a house in this plot. So he needs not more than 20 cents for the same.

Accordingly Form-6 notice of the said Act was issued for remitting an amount of Rs.1,51,688/-(Rupees One Lakh Fifty One Thousand Six Hundred and Eighty Eight Only)being the fee for regularization recommended by the Village Officer for the 20 cents of land.The original chalan.No.41 Dt.16/7/2016 Sub-Treasury Office regarding the payment of Rs.1,51,688/-(Rupees One Lakh Fifty One Thousand Six Hundred and Eighty Eight Only) in favour of applicant was submitted in this office .In this context, permission for regularization of 20 cents of land comprised in R.S 19/3 of Chelora Amsom Desom of Kannur Taluk is hereby granted as per G.O.(P)611/2015 Dt.17/11/2015 Kerala Conservation of Paddy Land and Wet Land (Regularisation of Unauthorised Reclamation) Rules 2015
